Main decisions and actions summary

- The SG Agreed to change the title of the work to "mapping" to reflect that no ranking is being proposed
- Suggestions to improve model, e.g. collate some criteria will be considered and acted on.
- Mapping shortlist and final selection to be two-tiered with firstly, any criteria and requirements related to
 recycling within the main metal schemes being collated and presented without further assessment of the
 schemes. Secondly, recycling focused schemes (e.g. ISRI, BIR guidance, RIOS, IWA 19: 2017, e-stewards,
 R2, The EU Battery Directive) to be assessed using the fuller model.
