


Mapping Next Steps

- 4. Finalising xls detailed mapping file which will contain all mapped scheme information
- 5. Sharing detailed mapping.xls with SG for review and use
- 6. Producing first draft mapping report, which summarises these findings and will form one of the 3 Roundtable deliverables
- 7. SG review of draft word version
- 8. Iteration of report
- 9. Design version produced
- 10. SG review, iteration and approval for publication
- 11. Publication and promotion


- Draft xls structure created

WG process

- Focus on themes and activities prioritised through interviews, landscaping and mapping stages (see later slides)
- Utilise existing evidence and expert input from WG participants and invited guests. WG's are not expected to do primary research
- Use questions and propositions to work through the thematic activities
- Bring the issues to life using WG member experience, real cases and context
- Summarise how each activity theme is currently managed/how current standards, guidance and tools meet expectations/requirements
- Summarise the nature and extent of key impacts/the issues with current approaches
- Highlight commonalities across metals and commodity specify requirements
- Confirm the gaps and provide proposals for how they can be closed
- Record issues to be put on shelf/not directly covered but relevant/to be considered
 if further time/scope to do so or highlighted as needing further work
