Outcomes and decisions

- The Summary Report will summarise landscaping, mapping and recommendations, the infographic will present a summary route map. These are the two key summarised outputs. They are supported by background reports for each of Landscaping, Mapping and Recommendations.
- The SG is kindly asked to consider the highest priority recommendations and to identify potential lead actors (specific named organisations) to take forward individual or recommendations themes. This is of key importance for continuity and per the original project plan and Terms of Reference.
- The public Recommendation Report should highlight a lead actor, but at the stakeholder group level, rather than a named organisation. These should be named in the xls.
- Continuity factors discussed include keeping the website active, being able to respond to interest generated by launch activities, and ability to respond to general queries. This is linked to the previous item and needs to be agreed before the Roundtable Secretariat disband.
- The launch plan is under development and needs the support of SG members.
- A proposal to run an additional SG meeting after the outputs have been launched to discuss interest generated and to recognise achievements and challenges was agreed. The date will be set in the new year once the launch plan and events are confirmed.
