### **Outcomes and decisions**

- The mapping work is almost concluded as final QC work and integration of the feedback received from scheme owners is being completed.
- Mapping work has taken longer than anticipated, partly due to almost doubling of mapped schemes (28 vs 15 initially identified)
- The RRRM survey that was shared with relevant stakeholders and their wider networks is concluded. Around 20 responses received and provided new stakeholder identification and some additional limited information. Parties that declared an interest have been invited to the Working Groups.
- Outreach to stakeholders is ongoing. Dave is invited to Aluminium Stewardship Initiative (ASI) Standards Board meeting 26<sup>th</sup> September from perspective of Lead Auditor + to share information on Roundtable. Dave liaising with Circularity Manager. More Civil Society representation is sought.
- The landscaping report is being drafted and behind schedule. Summaries are available to feed into Working Groups with draft report planned to be available for SG review prior to Octobers SG meeting
- Working Groups meetings start 12<sup>th</sup> September (NFWG) and 15<sup>th</sup> September (SSWG). Good interest in the working groups, in particular NFWG.
- Secretariat to draft terms for new funding category within Roundtable
- SG to review proposals and make decision at Oct SG meeting
- Secretariat to draft article updating on work of the Roundtable, aimed at Recycling and Metals publications.
